

The 2020 Election – President-Elect Biden at 290


- President-Elect Joe Biden is the projected winner with 290 votes.
 President Trump has 232 votes but has yet to concede.
- Georgia is undergoing an audit that should be completed this week, and President Trump's legal challenges in several states appear to be winding down.





The 2020 Election – The U.S. Senate: Undecided

- Control of the United States Senate has not been determined yet.
- Republicans were able to flip Alabama and hold Montana and Iowa.
- Democrats flipped Arizona and Colorado.
- There will be two runoffs in Georgia that will determine the majority in the U.S. Senate.

- IP issues generally tend to be nonpartisan
 - Rx Drug Pricing Reform and Patents
 - U.S. Supreme Court review of the Affordable Care Act (*California v. Texas*) and potential severability of, among other provisions, the Biologics Price Competition and Innovation Act (oral arguments were held on Nov. 10, 2020).
 - China IP Theft
 - Standard Essential Patents

- Covered Business Method (CBM) Patent Resurrection?
- Rise in ecommerce and anti-counterfeiting legislation to protect consumers and brands
 - Stopping All Nefarious Toys in America Act (SANTA Act)
