

## The 2020 Election – President-Elect Biden at 279


- Vice President Joe Biden is the projected winner with 279 votes. President Trump has 217 votes but has yet to concede.
- Georgia, North Carolina, and Arizona, remain undecided.
- Georgia is going to a recount.
   Pennsylvania is being litigated,
   and President Trump wants to
   prohibit PA from certifying the
   election.





## The 2020 Election – The U.S. Senate: Undecided

- Control of the United States
   Senate has not been determined yet.
- Republicans were able to flip Alabama and hold Montana and Iowa.
- Democrats flipped Arizona and Colorado.
- There will be two runoffs in Georgia that will determine the majority in the U.S. Senate.

### Trump Administration

- Continued rulemakings
- Continued litigation strategy
- Block Democratic legislation

### **Biden Administration**

- No Green New Deal, but aggressive
- Immediate freeze pencils down
- Administratively unwind, withdraw, repropose
- Tepid defense in courts (switch sides?)
- Team with a Democratic Congress on Congressional Review Act



## **VP Biden Plan**

- Re-enter the Paris Climate Accord
- Use of executive order to roll back Trump administration rollback of environmental standards, CAFE standards, Clean Air Act
- End planet warming pollution from electricity by 2035
- 100% clean energy and net zero emissions by 2050
- To spend *\$2 trillion over four years* in a piece-by-piece legislative approach:
  - Coronavirus Stimulus Package (example). 2009 American Recovery and Reinvestment Act had
     \$90 billion in clean energy infrastructure
  - 500,000 electric charging stations for vehicles (trucks) and 1.5 million energy-efficient homes in House T&I Bill
  - Mandate to purchase hybrid and electric vehicles
  - Carbon capture and sequestration
  - Farm equipment used to capture and store methane gas from manure
  - Environmental and climate justice for pollutants in communities of color and tribal lands, with 40% of all clean energy and infrastructure benefits



# **Congressional Review Act Primer**

- Congressional oversight tool
- Used 17 times (16 at the beginning of the Trump administration)
- Provides fast track consideration in Senate IF within 60 session day lookback period
- Invalidates the whole rule
- Prohibits agency from promulgating a rule in "substantially the same form"



## **Candidates for CRA treatment**

- WOTUS
- NEPA
- Methane
- Coal ash
- Scientific transparency
- Cost-benefit rule for CAA
- But remember, it's a blunt instrument and use can be double-edged



# **Hello Climate Change Policies**

- 100% Clean Energy Economy
- EPA and other agencies (Interior, NOAA, Forest Service, DOE, Ag, DOD)
- Carbon pricing legislation
- Infrastructure legislation (stimulus package)
- International agreements
- Legislation to empower EPA to regulate



# Don't forget the rest . . .

- Environmental justice a priority
- Safe drinking water regulation and infrastructure
- HFC phaseout
- Asbestos ban
- Pipeline safety
- Superfund tax
- Emphasis on biodiversity protections
- Administrative policies adverse to fracking and fossil fuels generally
