## 2012 Dollar Limits on Compensation and Benefits

The Internal Revenue Service (IRS) has announced the 2012 annual dollar limits on benefits, contributions, and compensation. The key limits for 2012 (as well as the limits that applied in 2011) are listed in the table below:
