Cause-Related Marketing in the Crosshairs: What the New York Attorney General's Breast Cancer Investigation Means for Nonprofits and Their Corporate Supporters

The New York Attorney General has recently crossed into what some consider to be the hallowed ground of charities, by launching an investigation into cause-related marketing of "pink ribbon" charities. In its own recognition of National Breast Cancer Awareness Month, the New York Attorney General's Office is examining charities and commercial partners that are involved in a cause-related marketing campaign representing that a portion of the sales of a product or service will support breast cancer research or screening. Overall, this initiative highlights the focus of the NY AG in preventing charitable fraud in breast cancer charities. This action also demonstrates that organizations, both charities and marketers, engaging in increasingly popular cause-related marketing campaigns should pay close attention to state regulatory requirements for these activities.

CFPB: October Roundup

Even though the Consumer Financial Protection Bureau does not yet have a director, the Bureau remains hard at work. With this Alert we identify the important steps that the Bureau undertook in October. Specifically, the CFPB:

- Published its Supervision Manual (1.0);
- Expanded its "Know Before You Owe" program;
- Addressed student loans; and
- Announced the head of the Office of Older Americans.

Gifting and Other Tax Planning Opportunities in 2011

The Tax Relief, Unemployment Insurance Reauthorization and Job Creation Act of 2010 provides for increased gift, estate and GST tax exemptions through the end of 2012. There is a rumor that the 12-member Congressional Super Committee may reduce this exemption sooner, even as soon as January 1, 2012. The Super Committee is working on legislative proposals to reduce a \$1.5 trillion deficit over a 10-year period. Thus, there is a concern that some part, if not all, of the \$5 million exemption may be reduced, resulting in missed opportunities for making gifts. Based on discussions with persons on Capitol Hill, Venable's legislative team believes there is no basis for this rumor.

The New D.C. Nonprofit Corporation Act Takes Effect on Jan. 1, 2012: Everything You Need to Know to Comply

The coming New Year will soon usher in a new legal landscape for District of Columbia nonprofit corporations. On January 1, 2012, the new District of Columbia Nonprofit Corporation Act of 2010 goes into effect. To ensure that your organization is ready to comply, now is the time to review your organization's articles of incorporation, bylaws, and governance policies and practices for any necessary changes.

Personal Conflicts of Interest: New FAR Challenges for Contractors

On November 2, 2011, the Civilian Agency Acquisition Council and the Defense Acquisition Regulations Council issued a final rule amending the Federal Acquisition Regulations by requiring contractors to identify and prevent personal conflicts of interest for contractor employees. Contracting officers are instructed to include the clause found at FAR 52.203-16 in all contracts, task orders and delivery orders issued after the effective date of December 2, 2011. Overall, the rule retains the general requirements established in the proposed rule for contractors to develop procedures identifying PCIs in their workforce and to prevent these conflicts of interest by not assigning or allowing employees with PCIs to work under a contract. The rule still requires contractor employees to execute non-disclosure agreements.

R.J. Reynolds Tobacco Co. v. FDA

The November 7, 2011, decision of Judge Richard J. Leon of the United States District Court for the District of Columbia preliminarily enjoining FDA's final rule requiring cigarette companies to place graphic and textual warnings on cigarette packages (*R.J. Reynolds Tobacco Co. v. United States Food and Drug Administration*, Civil Case No. 11-1482 (D.D.C.)) confirms that regulated entities should scrutinize agency rules from the perspective of the free speech implications of the rules.

U.S. Authorities Weigh in on Emerging Derivatives Model for Global Transport Sector

On October 13, the FMC issued a proposed rule that would clarify and ease Agency regulation of service contracts and NVOCC service arrangements ("NSA"). Under the current regime, the terms of such contracts or NSAs either must be explicitly stated or must be "contained in a publication widely available to the public and well known within the industry."

Virginia Supreme Court Recognizes the Evolving Nature of Non-Compete Law

On November 4, 2011, the Virginia Supreme Court issued its opinion in one of the two non-compete cases it agreed to hear this term. The Court in *Home Paramount Pest Control Cos., Inc. v. Shaffer*, reaffirmed that a non-compete cannot contain a blanket restriction on working for a competitor. Rather, a non-compete can only restrict post-employment activities that are competitive to the former employer; and a narrow reading of the provision will not save it.

Important News on Tax-Advantaged Venture Capital Schemes

The UK Government issued a consultation paper in July proposing big tax changes to the UK's venture capital scheme landscape. In a nutshell, a brand new tax relief, called "BASIS", is proposed, to encourage business angel investment for start-up businesses, and the existing Enterprise Investment Scheme (EIS) and Venture Capital Trust (VCT) schemes will be extended and simplified.
