# U.S. Coast Guard and Bureau of Safety and Environmental Enforcement Sign Agreement on Offshore Oversight

The Coast Guard and BSEE share jurisdiction over oil and gas operations on the Outer Continental Shelf (OCS).

# The Cyberlock Decision: District Court Rules That Non-Specific Teaming Agreements Are Unenforceable

Government contractors will want to review their teaming agreements following the recent decision in *Cyberlock Consulting, Inc. v. Info. Experts, Inc.* In *Cyberlock*, the U.S. District Court for the Eastern District of Virginia held that a teaming agreement expressing that the parties would negotiate a subcontract in the future was just an "agreement to agree" and thus unenforceable.
