On October 12, 2011, RCR Plumbing and Mechanical, Inc. commenced a chapter 11 case number 6:11-bk-41853-WJ pending in the [United States Bankruptcy Court for the Central District of California](#) in Riverside, California (“Bankruptcy Court”). The Honorable Wayne E. Johnson is the presiding judge.

#### **Committee Appointment**

On November 8, 2011, the [United States Trustee](#) appointed the committee of creditors holding unsecured claims (the “Committee”).
